## Staff Report for 2024 State Board of Equalization

**Appeal Issue:** Sterling Properties, LLLP, represented by Sam Jelleberg, is appealing the property value of \$2,538,000 on parcel number 01-6420-00260-000, located at 3720 42<sup>nd</sup> Street S, Fargo, ND.

**Analysis:** The Cass County Board of Equalization approved a 2024 true and full value of \$2,538,000, of which \$1,953,000 is attributable to the improvements and \$585,000 is attributable to the land.

Property Tax Division staff completed an onsite inspection on Wednesday, August 21, 2024, with representative Sam Jelleberg present. Staff also visited with Cass County Director of Tax Equalization, Paul Fracassi, and City of Fargo Assessor, Michael Splonskowski.

Foxtail Creek Townhomes, owned by Sterling Properties, LLLP, is a 2003 4-building, 2-story, 30-unit complex with detached garage space. Foxtail Creek Townhomes is made up of 2-bedroom, 3-bedroom, and 4-bedroom units.

The income approach to value was considered for this appeal. The calculated value per unit is \$66,100, resulting in an estimated value of \$1,984,300, which is lower than the county approved true and full value.

The cost approach to value was considered for this appeal. The calculated value per unit is \$105,900, resulting in an estimated value of \$3,176,100, which is higher than the county approved true and full value.

The sales approach to value was considered for this appeal. The calculated value per unit is \$91,965, resulting in an estimated value of \$2,758,962, which is higher than the county approved true and full value.



Upon review of all information submitted by Sterling Properties, LLLP, the City of Fargo, and Cass County, the three approaches to value were weighted. The per unit value reached is \$92,158 for the 30-unit complex which indicates a value of \$2,764,731 which is higher than the county approved true and full value of \$2,538,000. The difference is an opinion of assessment and could fluctuate depending on how the market is viewed and does not warrant a change.

**Summary:** The Cass County Board of Equalization approved a 2024 true and full value of \$2,538,000 on this 2003 4-building, 2-story, 30-unit complex. The three approaches to value indicate a value of \$92,158 per unit, which comes to a total value of approximately \$2,764,731, which is higher than the county approved value of \$2,538,000. The difference is an opinion of assessment and could fluctuate depending on how the market is viewed and does not warrant a change.
